1. SRE 2400 requires that we plan and perform our review to obtain moderate assurance as to whether the financial results are free from any material misstatement.


A review is limited primarily to inquiries of company personnel and analytical procedures applied to financial data and thus provides less assurance than an audit. We have not performed an audit and accordingly, we do not express an audit opinion.

3. We draw the attention to Note 2 to the Statement regarding non-ascertainment and non-provision of non-performing assets in pursuance to prudential norms prescribed by the Reserve Bank of India and deferred taxation, which will be made at the year-end.

Based on our review conducted as above and *subject to paragraph 3* herein above (the effect of which on the quarterly results are not ascertainable at this stage), nothing has come to our attention that causes us to believe that the accompanying statement for the quarter ended 30th June 2009, prepared in accordance with the applicable Accounting Standards notified by The Companies Act, 1956 of India and other recognised accounting practices and policies, has not disclosed the information required to be disclosed in terms of Clause 41 of the Listing Agreement, including the manner in which it is to be disclosed, or that it contains any material misstatement.
